Agreement to Sell

United States

This agreement, made this 30th day of October nineteen hundred and seven; between R.S. Moore and Clara A. Moore, his wife and C.S. Moore and Mary L. Moore, his wife, of Klamath County, Oregon, for their heirs, legal representatives and assigns, of the first part, and the United States of America and its assigns, of the second part, acting in this behalf by D.W.Murphy of the Un ited States Reclamation Service thereinto duly authorized by the Secretary of the Interior,

Witnesseth That the party of the first part, in consideration of the payment by the party of the second part of the sum of one dollar and of the premises and agreements of the perty of the second part, herein contained, does hereby agree, upon the terms and conditions hereinafter stated, to sell and by good and sufficient deed to convey to the United States of America, for the uses and purposes contemplated by the act of Congress approved June 17 1902, (32 Stat., 388), known as the Reclamation Act, the following described real estate and property situated in the county of Klamath town of Klamath Falls, State of Oregon, to wit: All of lot one of block one of West Linkville, Oregon, excepting a tract on the east side thereof, described as follows: all that part of lot one, block one of West Linkville, Oregon bounded on the east by the east line of said lot one; on the west by a line drawn from a point on the south line of said lot and 30 feet from the southeast corner of said lot to a point on the north line of said lot and 10 feet from the northeast corner thereof; on the north by 10 feet of the north line of said lot; on the south by 30 feet of the south side of said lot.
