C.S. Moore et al :
to : Agreement to Sell
United States

This agreement, made this 30th day of October nineteen hundred and seven, between R.S. Moore and Clara A. Moore, his wife and C.S. Moore and Mary L. Moore, his wife, of Klamath County, Oregon, for their heirs, legal representatives and assigns, of the first part, and the United States of America and its assigns, of the second part, acting in this behalf by D.W. Murphy of the United States Reclamation Service thereunto duly authorized by the Secretary of the Interior,

Witnesseth That the party of the first part, in consideration of the payment by the party of the second part of the sum of one dollar and of the premises and agreements of the party of the second part, herein contained, does hereby agree, upon the terms and conditions hereinafter stated, to sell and by good and sufficient deed to convey to the United States of America, for the uses and purposes contemplated by the act of Congress approved June 17, 1902, (32 Stat., 388), known as the Reclamation Act, the following described real estate and property situated in the county of Klamath town of Klamath Falls, State of Oregon, to wit: All of lot one of block one of West Linkville, Oregon; excepting a tract on the east side thereof, described as follows: All that part of lot one, block one of West Linkville, Oregon bounded on the east by the east line of said lot one; on the west by a line drawn from a point on the south line of said lot and 30 feet from the southeast corner of said lot to a point on the north line of said lot and 10 feet from the northeast corner thereof; on the north by 10 feet of the north line of said lot; on the south by 30 feet of the south side of said lot.

Also a tract of land, described as follows: Beginning at the northeast corner of said lot one of block one in said town of West Linkville; thence south 66-1/2 degrees west, 108 feet to northwest corner of said lot one; thence north 22-1/2 degrees west 250 feet to a stake; thence north 66-1/2 degrees east to the meander line on the west bank of Link River; thence southerly and easterly along said meander line to its intersection with a line running north 22-1/2 degrees east from the place of beginning; thence south 22-1/2 degrees west to the place of beginning. All in Sec. 32 Tp. 38 S. R. 9 E.W.M.

It is expressly understood that the parties of the first part reserve the right to construct, operate and maintain turnouts, pipes and flumes across and upon the said premises, in accordance with the agreement, dated October 16, 1905, between the said parties of the first part and the United States of America, subject to the terms and conditions thereof; that the said parties of the first part reserve an easement across said strips for public
