Fredrickson</u>,</p> <p>of the _____, County of <u>Klamath</u>, State of Oregon,  and of love and affection have bargained and sold, and by these presents do grant, bargain, sell and convey unto said <u>Leona J. Fredrickson</u>,</p>		
<p>an undivided one-half interest in  all the following bounded and described real property, retaining to myself a like undivided one-half interest therein, situated in the County of <u>Klamath</u>,  and State of Oregon; for the purpose of creating an estate in entirety between myself the grantor herein and my wife, the grantee herein:</p> <p>Part of the west half of southeast quarter of north-east quarter of Section 32, Township 39 South Range 8 East Willamette Meridian, described as follows:  Beginning at a point on the south line of the north-east quarter of Section 32 in Township 39 South, Range 8 East Willamette Meridian from which the quarter corner common to Sections 32 and 33 bears North <math>89^{\circ}31'</math> East 670 feet distant; thence North <math>0^{\circ}06'</math> East, 1109.50 feet to the southerly line of the Ashland-Klamath Falls Highway; thence along said line South <math>75^{\circ}21'</math> West 310.10 feet; thence South <math>0^{\circ}06'</math> West 1008.65 feet; thence North <math>89^{\circ}31'</math> East 320 feet to the point of beginning, containing 7.88 acres, more or less, saving and excepting therefrom that portion of the above described property contained within the westerly boundary thereof and a line parallel to and 120 feet easterly from the said westerly boundary thereof.</p> <p>Together with all and singular the tenements, hereditaments, and appurtenances thereto belonging or in anywise appertaining, and also my estate, right, title and interest, in and to the same.</p> <p><b>TO HAVE AND TO HOLD:</b> the above described and granted premises unto the said <u>Leona J.
