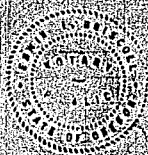

MORTGAGEE'S CONSENT TO RIGHT OF WAY GRANT

WHEREAS, The California Oregon Power Company, a California corporation, is about to accept from Rex E. High and Zella High, husband and wife

a grant for a right of way for the construction, maintenance and operation of an electric power line over and across the real property hereinafter described, and which property is encumbered by an existing mortgage to and owned by the undersigned mortgagee, which mortgage is of record in Volume 376, Page 24, of the Mortgage Records for Klamath County, Oregon, and the execution of this instrument is required by said The California Oregon Power Company before accepting said grant and constructing its power line across said premises in accordance therewith.
