AGREEMENT

THIS AGREEMENT, made and entered into this 23rd day of July, 1947,
by and between the State of Oregon, by and through its State Highway
Commission, hereinafter called "State", and Denver Parks and Victoria
Parks, husband and wife, hereinafter referred to as "Grantors", WITNESSETH:

RECITALS.

1. Grantors, on May 18, 1946, jointly with D. E. Noah, executed a
warranty deed in favor of the State of Oregon, by and through its State
Highway Commission, to property lying in Sections 24 and 25, Township 32
South, Range 7 East, W.N., Klamath County, Oregon, said warranty deed being
recorded in Book 190, Page 18, Deed Records of Klamath County,
Oregon.

2. Grantors have succeeded to all of the interest of D. E. Noah.

3. By inadvertence, the reserved point of access in said deed was
stated to be at Station 2236+00, whereas, it was the intention of the
parties that said reserved point be at Station 2326+00.

4. Grantors have requested an additional point of access at Station
2229+45, and State is willing to grant an access at said point, upon the
terms and conditions hereinafter set forth.

NOW, THEREFORE, the premises being generally as stated in the fore-
going recitals, IT IS AGREED by and between the parties, as follows:

1. Except as hereinafter provided, Grantors, for themselves, their
heirs and assigns, hereby affirm the terms and conditions of that cer-
tain warranty deed executed by them in favor of State, under date of May
18, 1946, and recorded in Book 190, Page 18, Deed Records of
Klamath County, Oregon.
