THIS INDENTURE WITNESSETH, That Don B. Miller and Jane R. Miller, husband and wife,

hereinafter known as grantor A, for and in consideration of the sum of Dollars, to them paid, have bargained and sold, and by these presents do grant, bargain, sell and convey unto John Blaylock and Esther Irene Blaylock, husband and wife, as an estate by the entirety,

their heirs and assigns, the following described premises, to-wit:

Tract 25, YALTA GARDENS, in Klamath County, Oregon; according to the duly recorded plat thereof in the office of the County Clerk of Klamath County, Oregon; subject, however, to reservations and conditions imposed by statutes, governmental rules and regulations and all conveyances to and contracts with the United States of America and/or the Enterprise Irrigation District and the following: All proceedings, taxes and assessments for the drainage, irrigation and/or reclamation of said lands; also all rights of way for roads, ditches, canals and conduits; and all water rights; and also subject to reservations and restrictions contained in the dedication of said Yalta Gardens as to roads, irrigation laterals, underground irrigation system and pot back lines, and an easement over all lots for future sewer or utilities along the back line of all lots; and also subject to the rights, if any, of the suburban rural fire protection district; and also subject to reservations and restrictions contained in a deed from Harvey C. Martin et ux and Irving E. Gray et ux to the Grantors herein, dated August 22, 1947 and recorded September 1, 1947 in Volume 224 at page 351 of Deed Records of Klamath County, Oregon; also subject to a mortgage executed by the Grantors herein to First Federal Savings and Loan Association of Klamath Falls, a federal corporation, dated August 26, 1948 and recorded September 1, 1948 in Volume 124 at page 503 of Mortgage Records of Klamath County, Oregon, given to secure payment of a note in principal amount of \$8,500.00, the balance of which the grantees herein expressly assume and agree to pay.
