A T A T E R A N T Y D E E D

KNOW ALL MEN BY THESE PRESENTS, That the City of Klamath Falls, a municipal corporation organized and incorporated under the laws of the State of Oregon, in consideration of the sum of \$10.00 to it paid by Clayton J. Burrell, husband and wife, as tenants in its entirety and not in community, has bargained and sold, and by these presents does bargain, grant, sell and convey unto the said Clayton J. Burrell and Adrienne A. Burrell, husband and wife, as tenants in its entirety and not in community, all the following bounded and described real property situated within Klamath County, Oregon, to-wit:

Lot 22, Block 8, Hillside Addition to the City of Klamath Falls, Oregon

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, and also all its right, title and interest in and to the same.

TO HAVE AND TO HOLD the above described and granted premises unto the said Clayton J. Burrell and Adrienne A. Burrell, husband and wife, as tenants in its entirety and not in community, their heirs and assigns forever. And the City of Klamath Falls, a municipal corporation, grantor above named, does covenant to and with Clayton J. Burrell and Adrienne A.
