his heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the

County of Klamath, and State of Oregon, bounded and described as follows, to wit:

A tract of land in the SW^{1/4} of the NW^{1/4} of Section 2, Township

39 South, Range 9 E. W. M.
 Beginning at a point Northerly 30 feet and N 89° 21' East along the Northerly right of way line of the Dalles California Highway a distance of 156.6 feet from the iron pin which marks the center of Section 2, Township 39 South, Range 9 E.
