In consideration of Two (\$10,000) Dollars  
to them paid by Lina Heim  
do hereby grant, bargain, sell and convey unto said Lina Heim, a widow,

her heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances situated in the  
County of Klamath and State of Oregon, bounded and described as follows, to-wit:

A tract of land described as follows: Beginning at a point on the Section line which lies North 0 degrees 18' East along the Section line a distance of 739.8 feet from the Southwest corner of Section 35, Township 38 South, Range 9 East, Willamette Meridian, in Klamath County, Oregon, and running thence: Continuing North 0 degrees, 12' East along the Section line a distance of 61 feet to a point; thence North 89 degrees, 59' East a distance of 344.1 feet to an iron pin; thence South 89 degrees 15' West a distance of 61 feet to an iron pin; thence South 89 degrees, 59' West a distance of 344 feet more or less to the point of beginning; said tract containing 0.48 acres more or less in the SW<sup>1/4</sup> of the NW<sup>1/4</sup> of the SW<sup>1/4</sup> of Section 35, Township 38, South, Range 9 East, Willamette Meridian, in Klamath County, Oregon.
