in consideration of one and no/100 DOLLARS,

to them paid by the United States of America in pursuance of the Act of June 17, 1902 (32 Stat. 388) and acts amendatory thereof or supplementary thereto have bargained and sold, and by these presents do grant, bargain, sell and convey unto said United States of America, its successors and assigns, all the following bounded and described real property, situated in the County of Klamath and State of Oregon:

All that portion of Lot three (3) of Section twenty-eight (28), Township thirty-nine (39) South, Range eleven and one-half (11-1/2) East, Willamette Meridian, in Klamath County, Oregon, included in a strip of land two hundred and sixty (260) feet width, extending one hundred and thirty (130) feet on each side measured at right angles to the centerline of the Lost River Channel Improvement of the Klamath Project, said centerline beginning at a point on the Section Line common to Sections twenty-seven (27) and twenty-eight (28) of aforesaid Township and Range from which point the Section Corner common to Sections twenty-one (21), twenty-two (22), twenty-seven (27), and twenty-eight (28) of aforesaid Township and Range bears North 09° 09' East a distance of 2109.03 feet and running thence North 48° 53' West a distance of 1249.7 feet more or less to a point on the North boundary line of said Lot three (3) of Section twenty-eight (28), Township and Range aforesaid, from which the Northeast corner of Section twenty-eight (28), Township and Range aforesaid bears North 35° 31' East 1598.1 feet distant.

The above described strip of land is for right-of-way for the Lost River Channel Improvement and includes all land within the above described limits lying southerly and westerly of the centerline of Lost River, from the East boundary line of Lot three (3) of Section twenty-eight (28), Township thirty-nine (39) South, Range eleven and one-half (11-1/2) East, Willamette Meridian, to the North boundary line of said Lot three (3) and contains an area of 5.62 acres, more or less.

Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and also all their estate, right, title and interest, in and to the same, including dower and claim of dower.
