Know All Men by These Presents, That Zella High and Rex E. High, her husband,

of the County of Klamath State of Oregon, in consideration of one and no/100 DOLLARS, to them paid by the United States of America in pursuance of the Act of June 17, 1902 (32 Stat. 383) and acts amendatory thereof or supplementary thereto, bargained and sold, and by these presents do grant, bargain, sell and convey unto said United States of America, its successors and assigns, all the following bounded and described real property situated in the County of Klamath and State of Oregon:

All that portion of Lots seven (7) and eight (8) of Section thirteen (13), Township thirty-nine (39) South, Range ten (10) East, Willamette Meridian, in Klamath County, Oregon, included in a strip of land three hundred and fifty (350) feet in width, extending one hundred and seventy-five (175) feet on each side measured at right angles to the centerline of the Lost River Channel Improvement, said centerline beginning at a point on a line 634 feet West of the East boundary line of Lot eight (8) of Section thirteen (13), Township and Range aforesaid and parallel thereto, from which the East Section corner common to Sections thirteen (13) and twenty-four (24), Township and Range aforesaid, bears South 29°26' East a distance of 3762.3 feet, more or less and running thence South 82°53' West a distance of 499.8 feet, thence on a curve right with a radius of 573.7 feet a distance of 212.3 feet measured on 100-foot chords, thence North 75°52' West a distance of 542.1 feet, thence on a curve right with a radius of 573.7 feet a distance of 446.7 feet measured on 100-foot chords, thence on a curve right with a radius of 1146.3 feet a distance of 80.0 feet more or less, measured on 100-foot chords to a point on the North boundary line of Lot seven (7) of Section thirteen (13), Township and Range aforesaid, from which the Section corner common to Sections eleven (11), twelve (12) thirteen (13) and fourteen (14), Township and Range aforesaid, bears North 43°47' West a distance of 2368.4 feet more or less.

The above-described strip of land is for right-of-way for the Lost River Channel Improvement, and includes all lands within the above-described limits lying Southerly and Westerly of the centerline of Lost River, and contains 7.92 acres, more or less.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and also all the estate, right, title and interest, in and to the same, including dower and claim of dower.

TO HAVE AND TO HOLD, the above-described and granted premises unto the said United States of America, its successors and assigns forever.
