DEED
BARGAIN AND SALE

Know All Men by These Presents, That Rex E. High and Zella T. High
husband and wife

of the County of Klamath State of Oregon
in consideration of one and no/100 DOLLARS,

to them paid by the United States of America in pursuance of the Act of June 17, 1902
(32 Stat. 388) and acts amendatory thereof or supplementary thereto have bargained and sold, and by
these presents do grant, bargain, sell and convey unto said United States of America, its successors
and assigns, all the following bounded and described real property, situated in the County of Klamath and
State of Oregon:

All that portion of Lots seven (7) and eight (8) of Section nineteen (19) and the
Northeast quarter of the Northeast quarter (NE 1/4) of Section thirty (30), all in
Township thirty-nine (39) South, Range eleven and one-half (11 1/2) East, Willamette
Meridian, in Klamath County, Oregon, included in a strip of land three hundred and
fifty (350) feet in width extending one hundred and seventy-five (175) feet on each
side measured at right angles to the centerline of the Lost River Channel Improvement,
said centerline beginning at a point on the East boundary line of Lot seven
(7) of Section nineteen (19), Township and Range aforesaid from which the section
corner common to Sections nineteen (19), twenty (20), twenty-nine (29) and thirty
(30), Township and Range aforesaid bears South 451.8 feet and running thence on a
curve left, the tangent to which bears South 640 4/5 West at said point of beginning
with a radius of 573.7 feet a distance of 183.8 feet measured on 100 foot chords,
thence South 46° 20' West a distance of 29.7 feet, thence on a curve right with a
radius of 573.7 feet a distance of 222.0 feet thence on a curve right with a radius
South 68° 22' West a distance of 333.2 feet measured on 100 foot chords, thence North
of 716.8 feet a distance of 1103.3 feet, thence on a curve left with a radius of
36° 58' West a distance of 260.4 feet measured on 100 foot chords, thence North
716.8 feet a distance of 466.5 feet more or less to a point on the West boundary
579 46' West a distance of 466.5 feet more or less to a point on the West boundary
line of Lot eight (8), Township and Range aforesaid, from which point the East
Section corner common to Sections thirteen (13) and twenty-four (24), Township
thirty-nine (39) South, Range ten (10) East, Willamette Meridian bears South 79°
14' West a distance of 1882.7 feet.

The above-described strip of land is for right-of-way for the Lost River
Channel Improvement and includes all lands within the above-described limits lying
southerly of the centerline of Lost River and runs from the East boundary of Lot
seven (7) to the West boundary of Lot eight (8) of Section 19, Township thirty-
nine (39) South, Range eleven and one-half (11 1/2) East, Willamette Meridian and
contains 11.04 acres more or less.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or
in anywise appertaining, and also all their estate, right, title and interest, in and to the same,
including dower and claim of dower.

TO HAVE AND TO HOLD, the above-described and granted premises unto the said United States
of America, its successors and assigns forever.
