KNOW ALL MEN BY THESE PRESENTS, That Zapadni Cesko - Bratrska Jednota
(Western Bohemian Fraternal Association, Lodge No. 222)

a corporation duly organized and existing under the laws of the State of Oregon
in consideration of ----- Dollars,
to it paid by Malin Community Cemetery Maintenance District, a corporation,

does hereby grant, bargain, sell and convey to said Malin Community Cemetery Maintenance District
a corporation, its successors and assigns,
together with and forever, the following real property, with the tenements, hereditaments and appur-
tenances thereto belonging, or in anywise appertaining; and also all the estate, right, title and interest,
at law and equity, therein and thereto, situated in the
County of Klamath and State of Oregon, bounded and described as follows, to-wit:

PARCEL #1: Beginning at the southeast corner of the one acre tract heretofore conveyed
by the Lakeside Company, a Corporation, to Zdruzeni Ceskych Farmaru Malin by deed dated
September 6, 1911, and recorded at Page 63 of Volume 35 of the Record of Deeds of Klamath
County, Oregon; thence North Four Hundred Eighteen (418) feet along the east line of said
one acre tract; and said line extended; thence East parallel to the south line of Section
10 in Township 41 South, Range 12 East Willamette Meridian, 627 feet; thence South 418 feet
to the South line of said Section 10; thence West 627 feet to the place of beginning,
containing 6 acres, more or less, in the Southwest quarter of Section 10, Township 41 South,
Range 12 East Willamette Meridian, less one acre on East side heretofore conveyed to
William Ash Carsley and Pearl A. Carsley.

PARCEL #2: One acre in the Southwest corner of the Southwest quarter of Section 10,
Township 41 South, Range 12 East Willamette Meridian.

PARCEL #3: Beginning at a point 208.72 feet North of the southwest corner of Section
10; Township 41 South, Range 12 East Willamette Meridian; thence North 208.28 feet;
thence East 208.72 feet; thence South 209.28 feet; thence West 208.72 feet to the place
of beginning.

PARCEL #4: A strip of land twenty feet in width off the East side of the northwest
quarter of the Northwest quarter of Section 15, Township 41 South, Range 12 East Willamette
Meridian.

TO HAVE AND TO HOLD the same to the said Malin Community Cemetery Maintenance
District corporation, its successors and assigns forever.
And the said Malin Community Cemetery Maintenance District corporation
does covenant with the said Zapadni Cesko - Bratrska Jednota
and its legal representatives forever, that it is lawfully
seized in fee simple of the above described and granted premises, and has a valid right to convey same;
that the said real property is free from all encumbrances,

and that it will and its successors shall WARRANT AND DEFEND the same to the said grantee, its
successors, heirs and assigns forever, against the lawful claims and demands of all persons whomsoever.
