GRANT OF RIGHT OF WAY

This Agreement, made this 21st day of September A. D. 19 48  
 by and between FRANCIS LILLY and LUCILLE LILLY, husband and wife.

parties of the first part, and THE CALIFORNIA OREGON POWER COMPANY, a California corporation, party  
 of the second part.

Witnesseth: That the said parties of the first part, for and in consideration of the sum of One Dollar (\$1.00)  
 to them in hand paid, the receipt whereof is hereby acknowledged, do hereby by these  
 presents grant, bargain, sell and convey to said party of the second part, its successors and assigns, a right of way for  
 its pole and wire lines and other facilities for the transmission and distribution of electricity, also the right to remove  
 the trees, including danger trees outside of the right of way, and make the clearing necessary or desirable for the pur-  
 pose aforesaid, across that certain real property, situated in Klamath  
 County, State of Oregon and more particularly described as the Northwest  
 one-quarter (1/4) of the Northwest one-quarter (1/4) of Section 36, Township  
 39 South, Range 12, East of the Willamette Meridian, excepting therefrom the  
 Easterly side lying North of canal which grantors reserve for road purposes.

Said right of way to be 10 feet wide, \_\_\_\_\_ feet on each side of the pole and wire line as now  
 surveyed through said premises or hereafter constructed.

Said parties of the first part grant to the party of the second part the right of ingress and egress to the  
 right of way for the purpose of erection, maintenance, repair, or removal of the second party's electrical and transmis-  
 sion equipment, but reserves the right to cultivate said right of way.
