its pole and wire lines and other facilities for the transmission and distribution of electricity, also the right to remove

pose aforesaid, across that certain real property, situated in _____ Klamath
County, State of _____ Oregon _____ and more particularly described as: the Northwest

39 South, Range 12, East of the Willamette Meridian, excepting therefrom the
Easterly side lying North of canal which grantors reserve for road purposes.

surveyed through said premises or hereafter constructed.

Said party of the first part grant _____ to the party of the second part the right of ingress and egress to the
right of way for the purpose of erection, maintenance, repair, or removal of the second party's electrical and transmis-
sion equipment, but reserves the right to cultivate said right of way.
