

DEED OF GIFT

THIS INDENTURE, Made this 24th day of December, in the year of Our Lord One Thousand Nine Hundred and Forty Eight.

BETWEEN

WITNESSETH: That the said party of the first part, for and in consideration of the love and affection which the said party of the first part has and bears unto the said party of the second part, as also for the better maintenance, support, protection and livelihood of the said party of the second part, do by these presents

GIVE, GRANT, ALIEN AND CONFIRM unto the said party of the second part, all to his heirs and assigns forever,

ALL that certain lot piece or parcel of land, situate, lying and being in the County of Lake State of Oregon, described as follows, to-wit:

The South half of the Southeast quarter of Section 15; and the North half of the Northeast quarter of Section 22; all in Township 28 South, in Range 15 east, of Willamette Meridian.

TOGETHER with all and singular the tenements, hereditaments and appurtenances thereto belonging, on in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

To HAVE AND To HOLD all and singular the above mentioned and described premises together with the appurtenances unto the said party of the second part, heirs and assigns forever.
