## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS THAT AUGUST L. ANDRIEU, also known as AUGUSTE L. ANDRIEU, AUGUSTE LEON ANDRIEU and A. L. ANDRIEU, of Klamath County, State of Oregon, Grantor, in the consideration of the sum of TEN and no/100 (\$10.00) DOLLARS and other valuable considerations to him in hand paid by MARY C. ANDRIEU, his wife, receipt of which is hereby acknowledged, does by these presents bargain, sell, grant and convey unto said MARY C. ANDRIEU, his wife, of Klamath County, State of Oregon, Grantee, her heirs and assigns, an undivided one-half interest in and to all the following described real property situated in Klamath County, State of Oregon, to-wit:

Lots Two (2) and Five (5) of Section 28, Township 40 South, Range 9 East of Willamette Meridian.

The West Half ( $\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) and the Southwest Quarter ( $SW\frac{1}{4}$ ) of the Northwest Quarter ( $NW\frac{1}{4}$ ) of Section 25; the West Half ( $\frac{1}{2}$ ) of the Northeast Quarter ( $NE\frac{1}{4}$ ), the Northwest Quarter ( $NW\frac{1}{4}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ), the Southeast Quarter ( $SE\frac{1}{4}$ ) of the Northeast Quarter ( $NE\frac{1}{4}$ ) and the East Half ( $\frac{1}{2}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section 26; all in Township 40 South, Range 9 East, W.
