 common to Sec. 27 & 28, Twp. 38 S. Range 9 E.W.M.; thence South forty-five
 degrees, thirty-one minutes west, a distance of 55.98 ft.; thence along the
 arc of a 170.22 ft. radius curve to the right (the long chord of which
 curve bears South seventy-six degrees, thirty-seven minutes west 175.76 ft.
 a distance of 184.69 ft.; thence North forty-six degrees, twenty-nine
 minutes east a distance of 284.84 ft.; thence South fifteen degrees,
 thirteen minutes east, a distance of 98.69 ft. to the point of beginning,
 containing forty-five hundredths of one acre, more or less.
