her heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Klamath, and of Oregon, bounded and described as follows, to-wit:

Beginning at a point on the East-West quarterline which lies North deg. 57' East a distance of 747.0 feet from the iron axel which marks the one-quarter section corner common to Sections 10 and 11, Town 39 S., R. 9 E., W.M. and running thence: Continuing North 88 deg. 57' East along the East-West quarterline a distance of 135.0 feet to a iron pin; thence North 1 deg. 12' West parallel to the west section line of said Section 11 a distance of 331.4 feet to a point; thence South 88 deg. 57' West parallel to the East-West quarterline a distance of 135.0 feet to a point; thence South 1 deg. 12' East a distance of 331.4 feet, more or less, to the point of beginning, said tract containing 1.02 acres, more or less, in the South half of Southwest quarter of Northwest quarter of Section 11, T. 39 S., R. 9 E., W.M., in Klamath County, Oregon.
