Know all Men by these Presents, That Charles F. Street and Lois E. Street, husband and wife, in consideration of ten and no/100 Dollars to them paid by the Shasta View Irrigation District, do hereby remise, release and forever QUITCLAIM unto the said Shasta View Irrigation District, and unto its successors, all their right, title and interest in and to the following described parcel of real estate, situate in the County of Klamath, State of Oregon, to-wit:

An easement (perpetual) in and to the following described parcel of land as a road way of ingress and egress over and across the same to what is known as the Shasta View Irrigation District Reservoir on the Albert Micka place, said easement being more particularly described as follows, to-wit:

A strip of land sixteen feet wide along and on the north side of the south line of the northeast quarter of the southeast quarter of Section 12 in Township 41, south of Range 12, E.W.M., and beginning at a point which is on the north line of said right of way, distant 150 feet west of the west boundary line of the Main Irrigation District Upper Ditch; thence, angling westerly, angling to the north so as to have the full 16 foot width on the north side of said line at a power pole set in the ground 84 feet, more or less, east of the shed of Albert Micka and wife, at which point said 16 feet shall all be north of said south line of said northeast quarter of said southeast quarter; thence, west on said north side and parallel with said south line, and with the south line of the northwest quarter of said southeast quarter, a distance of 210 feet, more or less, to a power pole set on said south line; thence, westerly and angling to the south in the same manner as on the east end of said easement, a distance of 29 feet, more or less, so as to being the full 16 feet of said easement over onto the land of said Micka and wife on the south side of said south line of the said northwest quarter of said southeast quarter of said Section, Township and Range. Also easement for right of way for ditches of the said Shasta View Irrigation District as now existing and constructed on grantors' land in said Section, Township and Range.

TO HAVE AND TO HOLD the same, together with all and singular the hereditaments and appurtenances thereto belonging or in anywise pertaining to the said Shasta View Irrigation District, its successors, and assigns forever.
