FOR AND IN CONSIDERATION of the sum of TEN DOLLARS (\$10.00) paid by Company to grantors, receipt whereof is hereby acknowledged, grantors hereby grant, bargain, sell and convey to Company the permanent and perpetual right and easement to construct and maintain normal 4-WP copper wires across the premises hereinafter described to the extent necessary for service to tenants in the building located upon said premises and such other customers in the vicinity as Company

The premises covered by this agreement are described as follows: Lot 5, Block 40 of the original town of Linkville, now City of Klamath Falls, Klamath County, Oregon.

The present location of said wire is upon certain angle iron supports and necessary braces constructed and maintained by Company at its own expense and located, one on the southwesterly corner of the building and one approximately 30 feet easterly on the southerly fire wall of the building with an anchor an additional distance easter! along said fire wall, and with additional braces and equipment. Grantors further grant the right of access to said facilities from the ground and over the roof of said building for the purpose of maintaining, servicing, replacing and adding thereto and agrees that Company at its own expense may relocate, change and reinstate the equipment necessary for such facilities without interference with grantors' use of the premises in the event of the destruction of said building or the changing or enlargement of said building by grantors.

Company covenants and agrees to take every reasonable precaution to avoid damage to the building in the installation, maintaining and change of said facilities and shall, at its own exprense, repair and replace all damage not necessarily resulting from the existence of such facilities. Company covenants and agrees to notify a representative of grantors, if reasonably possible, before entering upon the roof of said building and if such notice is not given in advance, to give such notice without delay after such work has been done.
