for them and their heirs, executors, administrators, successors, and assigns, herin-
after called the lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WITNESSETH: The parties hereto for the consideration hereinafter mentioned covenant and agree as follows:

2. The lessor hereby leases to the Government the following described premises, viz:

From the Southwest corner of Section 2, Township 40 South, Range 9 East, W.M., Klamath County, Oregon, proceed East 1877.4 feet to a point; thence North 1836.2 feet to a stake which is the Point of Beginning; thence North 00° 20' East 546.9 feet to a stake; thence North 27° 58' East 293.4 feet to a stake; thence South 89° 43' East 669.0 feet to a stake; thence South 00° 20' West 805.0 feet to a stake; thence North 89° 47' West 805.0 feet to the Point of Beginning. Bearings are true, assuming South section line of Section 2 to be true East and West. Above described area containing 14.5 acres, more or less, is located in the SW 1/4 of the SW 1/4 of Section 2, Township 40 South, Range 9 East, W.M., Klamath County, Oregon.
