DEED TO RESTRICTED INDIAN LAND

THIS INDENTURE, Made and entered into this 2nd day of July
one thousand nine hundred and forty-three, by and between Wilbur Crim, heir of Jennie
Clinton, Probate File Nos. 25775-14, 111641-16, E-169-50 JLR 20363 (I-S. 25575-14,
14779-19).of Chiloquin, Oregon,
Klamath Indian part Y of the first part, and Mellie Crim, wife of grantor,of Chiloquin, Oregon part Y of the second part:WITNESSETH, That said part Y of the first part, for and in consideration of the sum of
One Dollar (\$1.00), love and affectiondo hereby grant, bargain, sell, and convey
unto said part Y of the second part the following-described real-estate and premises situated in
Klamath County, State of Oregonon the Klamath Indian Reservation, to wit:Beginning at a point 2425 feet west and 660 feet south of the 1/4 section corner
between Sections 20 and 29, T. 35S., R. 7E., in the middle of the county road leading
from Klamath Falls to Klamath Agency; thence west 215 feet to the northwest corner of
lot 5 Sec. 29; thence south 660 feet to the southwest corner of said lot 5; thence east
475 feet to the middle of said county road; thence north 22° 28' west 707 feet along
said road to place of beginning, containing 5.51 acres, N.M., in Oregon.The lands hereby conveyed are subject to a lien, prior and superior to all other
liens for the amount of costs and charges due to the United States for and on account
of construction, operation, and maintenance of the irrigation system or acquisition of
water rights by which said lands have been or are to be reclaimed and the lien so
created is hereby expressly reserved in accordance with the provisions of the Act of
March 7, 1928 (45 Stat. 200-210), as supplemented by the Act of July 1, 1932
(47 Stat. 564 and 565).together with all the improvements thereon and the appurtenances thereunto belonging. And the said
part Y of the first part, for himself and his heirs, executors, and administrators,
do hereby covenant, promise, and agree to and with the said part Y of the second part,
her heirs and assigns, that he will forever warrant and defend the said premises against the
claim of all persons, claiming or to claim by, through, or under him only.To have and to hold said described premises unto the said part Y of the second part, his her
