

THIS CONTRACT, Made the 29 day of May 1955 between
L. G. Genger and Elaine T. Genger, his wife,
of the County of Klamath and State of Oregon, hereinafter called
the first party, and Henry J. Davis, a sole trader d/b/a Lane Pine Lumber
Logging job, of the County
of Klamath and State of Oregon, hereinafter called the second party,
WITNESSETH; That in consideration of the stipulations herein contained, and the payments to be made
as hereinafter specified, the first party heroby agrees to sell, and the second party agrees to purchase, the
following described real estate, situate in the County of Klamath State of
Oregon to-wit:

Northeast quarter of section 30, township 34 S., R. 8 E.W.M.,
subject to reservations in patent and to easements and rights of way
of record and those apparent on the land,
for the sum of seven thousand and no/100 Dollars (\$ 7000.00)
on account of which fourteen hundred and no/100 Dollars (\$ 1400.00)
is paid on the execution hereof (the receipt of which is hereby acknowledged by the first party), and the re-
mainder to be paid to the order of the first party with interest at the rate of six per cent per annum on the
dates and in the amounts as follows:
Interest annually on May 2d of each year and entire balance of
principal on or before three years from date hereof;
PROVIDED, however, that said entire balance with accrued interest
shall be paid prior to date second party commences cutting timber on said
land.

First party shall furnish second party purchaser's title insurance policy on execution thereof.
