WITNESSETH: That the said parties of the first part, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations to them in hand paid, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey to said party of the second part, its successors and assigns, a right of way for the installation of one anchor and guy on that certain real property, situated in Klamath County, State of Oregon

and more particularly described as:

That portion of the Southeast quarter (SE $\frac{1}{4}$) of the Northwest quarter

(NW $\frac{1}{4}$) of Section 31, Township 38S Range 11E, W.M.

Said parties of the first part grant to the party of the second part the right of ingress and egress to the right of way for the purpose of erection, maintenance, repair, or removal of the second party's electrical and transmission equipment, but reserves the right to cultivate said right of way.
