by and between SANTFORD JONES and ETHEL JONES, husband and wife,

part 185 of the first part, and THE CALIFORNIA OREGON POWER COMPANY, a California corporation, party of the second part.

Witnesseth: That the said part 185 of the first part, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations to them in hand paid, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey to said party of the second part, its successors and assigns, a right of way for its pole or tower and wire lines and other facilities for the transmission and distribution of electricity; also the right to install guys and anchors which are necessary or desirable outside of said right of way; also the right to remove the trees, including all trees outside of said right of way, which in the judgment of the grantee could or may fall across or upon said right of way or across or upon any guys anchored outside of said right of way; and to make the clearing necessary or desirable for the purposes aforesaid, across that certain real property situated in _____ Klamath County, State of Oregon, and more particularly described as

Lot One (1) Section 18, Township 39 South, Range 10 East, W.M.

Said right of way to be 18 1/2 feet wide, 6 feet on the South and 12 1/2 feet on the North side of the pole or tower and wire lines as now surveyed through said premises or hereafter constructed.

Said part _____ of the first part grant to the party of the second part the right of ingress and egress to the right of way for the purpose of erection, maintenance, repair, or removal of the second party's electrical and transmission equipment, likewise to include the right to construct and maintain access roads outside of the right of way as documented across upon the part of the party of the second part, but reserves the right to cultivate said right of way.
