15. That the Lessee shall neither transfer nor assign this—lesse without the prior written approval of the Department, provided, however, that this Condition 15 shall not apply to the placing of first mortgages, deeds of trust or similar liens on the lessehold pursuant to the Statute.

7 16. That all notices given pursuant to this lease shall be sent by registered mail and addressed to the Lessee at Kingeley Field, Oregon, or to the Department at Washington 25, D. C., or as may otherwise from time to time be directed in writing by the parties hereto.

17. That the Department shall have the right, at its option upon sixty (60) days notice to the Lessee, to terminate this lease and all rights of the Lessee hereunder at any time after the Commissioner and the mortgagee have certified to the Department that the respective rights of the Federal Housing Administration and the mortgagee in this lease and in any mortgage on the leased premises and the Project thereon as insurer or otherwise has been fully terminated.

18. That except as otherwise specifically provided in this lease, all disputes concerning questions of fact which may arise under this lease, and which are not disposed of by mutual agreement, shall be decided by the Contracting Officer, Kingsley Field, Oregon, who shall reduce his decision to writing and mail a copy thereof to the Lessee at its address shown herein. Within thirty (30) days from said mailing the Lessee may appeal to the Secretary of the Air Force, whose written decision or that of his designated representative or representatives or board, shall be final and conclusive upon the parties hereto. Pending decision of a dispute hereunder the Lessee shall proceed with the performance of this lease in accordance with the Contracting Officer's
