# The United States of America,

To all to whom these presents shall come, Greeting:

WHEREAS, an Order of the authorized officer of the Bureau of Indian Affairs is now deposited in the Bureau of Land Management, directing that a fee simple patent issue to the Weyerhaeuser Timber Company, purchaser of land included in the allotment of Morris Smith, described as follows:

Willamette Meridian, Oregon.

T. 36 S., R. 11 E.,

Sec. 27, NW<sup>1/4</sup>.

The area described contains 160.00 acres, according to the Official Plat of the Survey of the said Land, on file in the Bureau of Land Management:

NOW KNOW YE, That the UNITED STATES OF AMERICA, in consideration of the premises, HAS GIVEN AND GRANTED and by these presents DOES GIVE AND GRANT unto the said Weyerhaeuser Timber Company and to its successors the Land above described; TO HAVE AND TO HOLD the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereto belonging, unto the said Weyerhaeuser Timber Company and to its successors and assigns forever. This patent is issued under authority of Section one of the Act of June 25, 1910 (36 Stat. 855), and is subject to the reservation of all subsurface rights, except water, to the heirs of Morris Smith, their heirs and assigns, under the terms approved by the Secretary of the Interior March 25, 1946, pursuant to said Act.

IN TESTIMONY WHEREOF, the undersigned authorized officer of the Bureau of Land Management, in accordance with the provisions of the Act of June 17, 1948 (62 Stat. 476), has, in the name of the United States, caused these letters to be made Patent, and the Seal of the Bureau to be hereunto affixed.

GIVEN under my hand, in the District of Columbia, the TWENTY-SIXTH day of DECEMBER in the year of our Lord one thousand nine hundred and FIFTY-SEVEN and of the Independence of the United States the one hundred and EIGHTY-SECOND.
