This Indenture witnesseth, THAT John A. Thornburg and Patricia M. Thornburg, husband and wife,

hereinafter known as grantors for and in consideration of the sum of - - - - - Ten and no-100ths - - - - - Dollars, to them paid, have bargained and sold, and by these presents do grant, bargain, sell and convey unto Elmer A. McGinnis and Neva G. McGinnis, husband and wife, the following described premises, situated in Klamath County, Oregon, to-wit:



Lot 15 of Elm Park, Klamath County, Oregon, according to the official plat thereof on file in Klamath County, Oregon.

Subject to contract and/or lien for irrigation and/or drainage, easements and rights of way of record and those apparent on the land, building restrictions and reservations of record, as set forth in deed executed by Henry A. Nitschelm et ux to Lloyd W. Rusk et ux, dated February 26, 1942, recorded February 28, 1942 in Vol 145, at page 352 of Klamath County Deed Records, and subject to mortgage from grantors to First Federal Savings and Loan Association of Klamath Falls, dated December 17, 1955, recorded December 22, 1955 in Vol 138 of Mortgages, page 139, records of Klamath County, Oregon, which mortgage grantees expressly assume and agree to pay as the same becomes due.
