GRANT OF RIGHT OF WAY

THIS AGREEMENT, made this 12 day of February, A.D. 1958

by and between

MILTON CONQUERGOD and MAUDE CONQUERGOD, husband and wife,

parties of the first part, and THE CALIFORNIA OREGON POWER COMPANY, a California corporation, party of the second part.

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations to them in hand paid, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey to said party of the second part, its successors and assigns, a right of way for the installation of 1" anchor and guy on that certain real property, situated in Klamath County, State of Oregon

and more particularly described as

The Northeast Quarter (NE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section 35, Township 38 South, Range 11 East, W. M.

Nothing herein contained shall be construed as making the party of the second part an operator, owner or person in possession as defined by the Oregon Forestry Code, namely, Chapter 477 of Title 38, O. R. S.

Said part 1st of the first part grant to the party of the second part the right of ingress and egress to the right of way for the purpose of erection, maintenance, repair, or removal of the second party's electrical and transmission equipment, but reserves the right to cultivate said right of way.
