LAND STATUS REPORT

Pursuant to the Act of February 8, 1887 (24 Stat. L. 388-89) Trust Patent No. 115678, dated March 7, 1910, was issued to JULIA JEFFERSON, Klamath allottee No. 413, for lands described as E $\frac{1}{2}$ SW $\frac{1}{4}$ section 25, Lots 1, 2, 7 & 8 section 18, Township 36 South, Range 11 East, Willamette Meridian, Oregon, containing 160 acres, more or less.

1. There have been subsequent transactions, since issuance of the above patent, affecting acreage or ownership, other than probate.
 - a. Fee Patent No. 776071 issued October 2, 1920, to Chas. E. Drew for Lots-1, 2, 7, 8 section 18, Township 36 South, Range 11 East, Willamette Meridian, Oregon, containing 80 acres.

This report continued to show the chain of title to that part of the above allotment described as E $\frac{1}{2}$ SW $\frac{1}{4}$ section 25, Township 36 South, Range 11 East, Willamette Meridian, Oregon, containing 80 acres, more or less.

2. This land is not under any Indian Irrigation Project.
3. There are no encumbrances of record. The following reservations are made:
 - a. Right of way to Klamath County Court, Oregon, for a highway, approved by T. A. Walters, First Assistant Secretary, on June 20, 1933, subject to the provisions of the Act of March 3, 1901 (31 Stat. L., 1084), and Departmental regulations thereunder; and subject also to any prior valid existing right or adverse claim.
 - b. A Fire Road constructed by the United States, with the rights of the United States to maintain, operate, or improve the same so long as needed or used for or by the United States. (Dept. Instr. January 13, 1916, 44 L.D. 513).
4. The land is presently owned by the persons listed, together with their respective shares, through the following probate proceedings:

Julia Jefferson, dec'd (died 7/2/23) Probate File No. 69581-23.
 Evans Tecumseh, dec'd (died 7/24/27) Probate File No. 1677-28.
5. There are no unpaid probate fees of record.
6. There is no record of indebtedness to the United States or the Klamath Tribe against the land.
7. Inspection was made of the records of Klamath County on August 29, 1957. No recording was found adversely affecting title to the land.

8. This allotment, being a part of the Klamath Indian Reservation, is subject to the provisions of the Act of August 13, 1954 (68 Stat. 718).
