LAND STATUS REPORT

Pursuant to the Act of February 8, 1887 (24 Stat. L. 388-89), Trust Patent No. 115675, dated March 7, 1910, was issued to LIZZIE JEFFERSON, Klamath allottee No. 410, for lands described as NW 1/4 section 36, Township 36 South, Range 11 East, Willamette Meridian, Oregon, containing 160 acres, more or less.

1. There have been no subsequent transactions since issuance of the above patent, affecting acreage or ownership, other than probate.
2. This land is not under any Indian Irrigation Project.
3. There are no encumbrances of record. The following reservation is made:
 - a. A Fire Road running north and south on the west boundary and a Fire Road running north and south on the east boundary constructed by the United States, with the rights of the United States to maintain, operate, or improve the same so long as needed or used for or by the United States. (Dept. Instr. January 13, 1916, 44 L.D. 513).
4. The land is presently owned by the persons listed in Paragraph 9 of this report, together with their respective shares, through the following probate proceedings:

5. There are no unpaid probate fees of record.
6. There is no record of indebtedness to the United States or the Klamath Tribe against the land.
7. Inspection was made of the records of Klamath County on August 29, 1957, and it was found that the S 1/4 of this tract is included in a general patent from the United States of America to the State of Oregon for School land purposes. Patent recorded in Book 24, page 579-80.

8. This allotment, being a part of the Klamath Indian Reservation, is subject to the provisions of the Act of August 13, 1954 (68 Stat. 718).
