GIENGER'S records for the purpose of determining the accuracy of the log scale.

2. To comply with all State and Federal Laws applicable to the logging of the timber from the above mentioned real property.

3. To cut and remove the timber in a good and workmanlike manner with as little injury to the remaining timber and soil as is consistent with normal logging practices.

IT IS MUTUALLY UNDERSTOOD AND AGREED AS FOLLOWS:

1. If GIENGER shall not have started removing timber by the 10th day of August, 1958, the additional sum of One Thousand and no/100 (\$1,000.00) Dollars will be paid on said date and will be applied on the first timber to be removed. If he shall not have started logging by the first of February, 1959, an additional One Thousand and no/100 (\$1,000.00) Dollars shall be paid and said sum, together with the One Thousand and no/100 (\$1,000.00) Dollars paid August, 1958, shall be applied on the first timber removed.

2. Payment for timber shall be made on bond scale.

3. Should any of the timber herein sold be not removed prior to 1962, and taxes for the years 1959, 1960, and 1961 be assessed on said timber, GIENGER will pay such taxes, taxes for prior years to be paid by KNIGHT.

4. If all of the timber herein sold shall not have been removed from the above described premises prior to the 10th day of December, 1962, the title thereto shall revert in KNIGHT and any sums in KNIGHT's hands shall become the property of KNIGHT as damages for failure to remove the said timber prior to the 10th day of December, 1962.

5. Should KNIGHT, at anytime, be dissatisfied with the scale furnished by GIENGER, the parties hereto shall hire and jointly (3-Contract)

bear the expense of a scaler satisfactory to both parties and the scale of such scaler shall be binding upon both parties.
