ORDINANCE NO. 1937

AN ORDINANCE VACATING ALL OF THE ALLEYS IN BLOCK 34, HOT SPRINGS ADDITION TO THE CITY OF KLAMATH FALLS, KLAMATH COUNTY, STATE OF OREGON.

WHEREAS, a petition was filed with the Common Council of the City of Klamath Falls, Klamath County, Oregon, by School District No. 1 of Klamath County, State of Oregon, a School District duly and lawfully organized under the laws of the State of Oregon, on the 13th day of August, 1928, praying for the vacation of three alleys in Block 34, Hot Springs Addition to the City of Klamath Falls, Oregon, more particularly described as follows, to-wit:

Beginning at the Northeast corner of Lot 12, thence South to the Southeast corner of Lot 17; thence 20 feet East to the Southwest corner of Lot 18; thence North to the Northwest corner of Lot 18; thence East to the Northeast corner of Lot 22; thence South to the Southeast corner of Lot 22; thence East 20 feet to the Southwest corner of Lot 6; thence North to the Northwest corner of Lot 1; thence West 20 feet to the Northeast corner of Lot 7; thence South to the Southeast corner of Lot 7; thence West to the Southwest corner of Lot 11; thence North to the Northwest corner of Lot 11; thence West 20 feet to the place of beginning; all of the aforesaid lots being situated in Block 34, Hot Springs Addition to the City of Klamath Falls, Oregon.

And, WHEREAS, the said petition was published in the Klamath Falls News, the City official newspaper, as provided by the City Charter, when notice was given with the publication of publication, to all the owners of the lots in Block 34, that the said School District No. 1 would on and after the 13th day of August, 1928, present its petition to the Common Council, praying for the vacation of said alleys as aforesaid; and

WHEREAS, said petition filed on the 13th day of August, 1928, came on for hearing, and the Council designated the 20th day of August, 1928, as the day for hearing the objections to the said petition; and

WHEREAS, no objections have been filed and it appears that the said School District No. 1 is the only existing property owner affected by said alleys;

And the Common Council having examined the said petition and said petition, does now find that the consent of every owner of the abutting property owners of the said alleys has been obtained, and it further appearing that the public interests would not be injured by the vacation of said alleys as aforesaid for, THEREFORE,

The City of Klamath Falls Ordains as follows:

Section 1.

That the petition of said School District No. 1, filed with the City Clerk on the 13th day of August, 1928, praying for the vacation of all of the alleys of Block 34, Hot Springs Addition to the City of Klamath Falls, Oregon, more particularly described as follows, to-wit:

Beginning at the Northeast corner of Lot 12, thence South to the Southeast corner of Lot 17; thence 20 feet East to the Southwest corner of Lot 18; thence North to the Northwest corner of Lot 18; thence East to the Northeast corner of Lot 22; thence South to the Southeast corner of Lot 22; thence East 20 feet to the Southwest corner of Lot 6; thence North to the Northwest corner of Lot 1; thence West 20 feet to the Northeast corner of Lot 7; thence South to the Southeast corner of Lot 7; thence West to the Southwest corner of Lot 11; thence North to the Northwest corner of Lot 11; thence West 20 feet to the place of beginning; all of the aforesaid
