Beginning at a point on the Southwesterly line of Spring Street in Second Hot Springs addition to the City of Klamath Falls, Oregon, which is North thirty-three (33) degrees 04 minutes West, a distance of 60.57 feet from the most Easterly corner of Lot twenty-two (22) in Block five (5) of said addition; thence South fifty-six (56) degrees, fifty-six (56) minutes West, 11.31 feet, to a point on the Southwesterly line of the alley in said Block five (5), which point is the most westerly corner of Lot twenty-one (21) of said Block; thence North twenty-nine (29) degrees, thirty-four (34) minutes West, along the Southwesterly line of said alley, a distance of 43.73 feet; thence North fifty-six (56) degrees, fifty-six (56) minutes east 76.13 feet, to the Southwesterly line of said Spring Street; thence South thirty-three (33) degrees 04 minutes East, along the Southwesterly line of said Spring Street, a distance of 20 feet to the point of beginning, being a portion of Lots 21 and 22, of Block 5, Second Hot Spring Addition to the City of Klamath Falls, Klamath County, Oregon.

And that, said UNION HIGH SCHOOL DISTRICT NO. 2, cause same to be graded and paved in a manner that it will be at least as substantial and servicable as that portion of said alley being hereby vacated.

Section III.

In as much as this ordinance is necessary for the immediate protection of the public peace, health and safety of the city of Klamath Falls, Oregon, an emergency is hereby declared to exist in the case of this ordinance and the same shall be in full force and operation from and after its passage, three-fourths of aye and nay vote of the Common Council and its approval by the Mayor.
