ORDINANCE NO. 4977

AN ORDINANCE CALLING A SPECIAL ELECTION IN THE CITY OF KLAMATH FALLS, OREGON, ON FRIDAY THE 16th. DAY OF MAY, 1958, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF SAID CITY, A CHARTER AMENDMENT AND PROPOSITION PROPOSED BY THE COMMON COUNCIL OF SAID CITY PROVIDING FOR COUNCIL MANAGER ADMINISTRATION OF SAID CITY, AND A CHANGE IN THE READING OF ORDINANCES, PROPOSED FOR ADOPTION, BY THE COMMON COUNCIL, WHICH CHARTER AMENDMENT AND PROPOSITION ARE SUBMITTED TO THE PEOPLE UNDER AND BY VIRTUE OF ORDINANCE NO. 4563, DULY ENACTED AND PASSED BY THE COMMON COUNCIL OF THE CITY OF KLAMATH FALLS, OREGON, AND PROVIDING FOR THE CARRYING INTO EFFECT IN THE SAID CITY, THE INITIATIVE AND REFERENDUM BY SECTION I - A ARTICLE IV OF THE CONSTITUTION OF THE STATE OF OREGON, AND TO ENACT AND AMEND THEIR MUNICIPAL CHARTER CHARTER RESERVED TO THE LEGAL VOTERS OF CITIES AND TOWNS BY SECTION II, ARTICLE XI OF THE CONSTITUTION OF SAID STATE; AUTHORIZING AND DIRECTING THE POLICE JUDGE TO PUBLISH NOTICES OF SAID ELECTION, DESIGNATING THE POLLING PLACES AND THE JUDGES AND CLERKS OF SAID ELECTION, APPROPRIATING MONEY FOR SAID ELECTION; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY.

WHEREAS, the Common Council of the City of Klamath Falls, Oregon, under and by virtue of the laws of Oregon, the City Charter of said City, and Ordinance No. 4563, of said City of Klamath Falls, Oregon, the same being an ordinance providing for the carrying into effect in the City of Klamath Falls, Oregon, the initiative and referendum powers reserved to the legal voters of municipalities by section I - A, Article IV of the Constitution of the State of Oregon, duly adopted, enacted and passed by the Common Council of the said City, of Klamath Falls, Oregon, on the 9th. day of February, 1953, and approved by the Mayor on the 9th. day of February, 1953, having by resolution submitted to the qualified electors of the City of Klamath Falls, Oregon, a certain charter amendment and proposition, providing for a Council Manager form of administration of Klamath Falls and amending section 77 of said City charter which provides for the reading of proposed ordinances by the Common Council before the adoption thereof, and to amend the Charter of said City so that the objective and purpose of said resolution may be accomplished, which resolution was duly read and adopted by the Common Council of the City of Klamath Falls, Oregon, on
