KNOW ALL MEN BY THESE PRESENTS, That *Jack Miller and Helen Miller his wife*

in consideration of *Ten* Dollars,  
to them paid by *Fred D. Fletcher and Elda R. Fletcher, his wife*

do hereby grant, bargain, sell and convey unto said *Fred D. Fletcher and Elda R. Fletcher, his wife,*

not as tenants in common but with the right of survivorship, their assigns and the heirs of such survivor, all the following real property, with the tenements, hereditaments and appurtenances situated in the County of *Klamath* and State of *Oregon*, bounded and described as follows, to-wit:

Lot 237 of the Southern portion of Tracts B and C of Frontier Tracts, according to the official plat thereof on file in the records of Klamath County, Oregon.

Subject to the reservation that no commercial enterprise or enterprises shall be operated on the above described property as set forth in deed from Frontier Guest Ranch, a corporation to Jack Miller and Helen Miller his wife dated July 8th, 1960.

the grantor above named, do covenant to and with the above named grantees, their heirs and assigns, that they are lawfully seized in fee simple of the above granted premises; that the above granted premises are free from all encumbrances, except as hereinabove set forth

and that they will and their heirs, executors and administrators, shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever, except as hereinabove set forth.
