

Maintenance, so that the roads shall be left at the termination of each such use in a condition equal to that obtaining at the beginning thereof; provided further, with respect to use of the roads for log hauling, that when either a purchaser of Government timber or the Grantor is using any road section for log hauling, and a Government timber purchaser or the Grantor, as the case may be, desires to commence an operation that would require use of the same road section and such use would interfere with the operations of the Government purchaser or the Grantor, as the case may be, then using the road, then the party desiring to commence such use shall, at its own expense, widen the road or build a crossing, as the case may be, so as not to interfere unduly with the use of the party then using the road for log hauling.

The Grantor reserves to itself, its successors and assigns, all timber on said rights-of-way, provided that the Government or its timber purchasers shall have the right, subject to advance approval by the Grantor, to cut timber upon the right-of-way to the extent necessary for the reconstruction or betterment of said roads. Such timber shall be cut into logs of standard length with proper trim allowance and shall be decked horizontally along said highway and shall be free from stumps, limbs or other debris and placed at locations approved by the Klamath Falls Branch of the Grantor.

The Grantor expressly reserves the right to enter upon such strips of land to remove said decked timber and remove standing timber in the usual and customary manner.

The rights, privileges, and authorities herein granted shall continue as long as used for the purposes granted, but if the Government shall cease for a period of five (5) years to use the rights, privileges, and authorities for the purposes granted or shall abandon the use of the easement herein granted, then, in any such event, all rights hereunder shall revert to the holder of the fee title to the land.

Subject to the foregoing limitations, the rights, privileges, and authorities herein granted are for full use and enjoyment by the Government and persons hauling timber purchased from the Government, for any and all purposes deemed necessary or desirable in connection with the control, management, and administration of the National Forest, or the resources thereof and, insofar as compatible therewith, the Government may extend such rights and privileges to others, provided such use by others shall be controlled so it will not, in the opinion of the Regional Forester, interfere unduly with the use of the road by the Grantor.
