## GRANT OF RIGHT OF WAY

THIS AGREEMENT, made this 13 day of July, A.D. 1966, by and between  
REINHOLD KLATT and BESSIE B. KLATT, husband and wife, and PAUL MCATEE and  
EVELYN F. MCATEE, husband and wife, as their interests may appear,

part of the first part, and THE CALIFORNIA OREGON POWER COMPANY, a California corporation, party of  
the second part:

WITNESSETH: That the said part 10c of the first part, for and in consideration of the sum of One Dollar  
(\$1.00) and other good and valuable considerations to them in hand paid, the receipt whereof is hereby  
acknowledged, do by these presents grant, bargain, sell and convey to said party of the second part, its  
successors and assigns, a right of way for the installation of one anchor and guy on that  
certain real property, situated in Klamath County, State of Oregon.

and more particularly described as  
beginning at a point on the Southwesterly line of Lot 2, Block 3, First Addition to  
Senate Number 1955 feet Southwesterly from the Southwesterly corner of said Lot 2,  
thence North 30° 30' East a distance of 30 feet; thence South 59° 30' East a distance  
of 5 feet; thence South 30° 30' West a distance of 13 feet; thence North 59° 30' West  
a distance of 5 feet to the point of beginning.

This grant of right of way is given to correct that certain Grant of Right of Way executed by  
Reinhold Klatt and Beessie B. Klatt, husband and wife, and Paul Mcatee and Evelyn F. Mcatee,  
and recorded May 23, 1960, in Volume 321, Page 336, Klamath County Land Records, wherein the descrip-  
tion involved is in error and this is intended as a correction thereof.

Said part 10c of the first part grant, to the party of the second part the right of ingress and egress to  
the original road, for the purpose of erection, maintenance, repair, or removal of the second party's electrical and  
transmission equipment, but reserving the right to cultivate said right of way.

Nothing herein contained shall be construed as making the party of the second part an operator, owner or  
person in possession as defined by the Forestry Code of the respective States of either Oregon or California,  
whichever State may be the one wherein the premises, which are the subject matter hereof, are located.
