GRANT OF OVERHANG EASEMENT

KNOW ALL MEN BY THESE PRESENTS THAT REINHOLD KLATT and BESSIE B. KLATT, husband and wife, as their interests may appear,

in consideration of One Dollar (\$1.00) and other valuable consideration to them paid, receipt of which is hereby acknowledged, hereby grant and convey unto THE CALIFORNIA OREGON POWER COMPANY, a California corporation, its successors, and assigns an easement right of way and rights as follows:

- To construct or maintain electrical circuits and or associated property of whatever nature in or position to overhang the lands described herein.
- To enter upon said land with necessary tools and machinery for the purpose of installing, maintaining, or removing said circuits and/or associated property and
- To remove or trim trees and make the clearing on or over said lands to the extent necessary or desirable.
- Provided however that no poles, towers or anchors shall be erected upon the lands described herein.

The lands subject to this right of way and easement are situated in Klamath.

County, Oregon, and described as follows:

Access Lot 12, Block 3, First Addition to Tomatee Homes, the center line of said

overhanging easement being described as follows:

Beginning at a point on the Southwesterly lot line of said Lot 12, 9 feet distant from the Southeasterly line of the said subdivision, when measured at right angles thereto; thence North 47° 12' East, parallel to and 9 feet distant from the said Southeasterly line of the said subdivision to the Northerly line of said Lot 12.

said overhanging easement to be ten feet wide, five feet on each side of the center line of the said width line as now surveyed through said premises.

This Overhanging Easement is given to correct that certain Overhanging Easement executed by Reinhold Klatt and Bessie B. Klatt, husband and wife, and Paul McAttee and Evelyn F. McAttee, husband and wife, as their interests may appear, to the California Oregon Power Company dated April 27, 1960 and recorded May 23, 1960, in Volume 321, page 334, Klamath County Deed Records wherein the description involved is in error and this is intended as a correction thereof.

Nothing herein contained shall be construed as making The California Oregon Power Company an operator, owner or person in possession, as defined by the Forestry Code of the respective States of either Oregon or California, whichever State may be the one wherein the premises, which are the subject matter hereof, are located.
