EASEMENT FOR DITCH

KNOW ALL MEN, that HANKINS FARMS, INC., an Oregon corporation, for and in consideration of the sum of TEN AND NO/100TH DOLLARS and other valuable consideration to it paid by WALTER W. CASEBEER, has given and granted and by these presents does hereby give, grant and convey unto the said WALTER W. CASEBEER, an easement, 30 feet in width, over and across the following described strip of real property situated in Klamath County, Oregon, to-wit:

The Southeasterly 200 feet lying South of and adjacent to the County Road running through said quarter section, and beginning at the Easterly section line and running thence in a generally Northwesterly direction to an intersection with the irrigation ditch now in existence running in a generally Northeasterly - Southwesterly direction through said quarter section, all being in the SEK of Section 6, T 39 South of R 11 East, W.M.

for the purpose of maintaining therein an irrigation ditch, together with the right to maintain within said 200 foot strip, the same, excavated therefrom, and together with the further right of the grantor his agents and employees to enter upon said strip for the purpose of construction and maintenance of said irrigation ditch and to install and operate if desirable, headgates or other regulatory devices.

TO HAVE AND TO HOLD the same unto the said grantee, his heirs and assigns forever.
