Horn and Lola Horn, his wife, in consideration of Ten Dollars to them paid by Horsefly Irrigation District, do hereby remise, release and forever quitclaim unto the said Horsefly Irrigation District, its successors and assigns, all their right, title and interest in and to the following described real property, with the tenements, hereditaments and appurtenances, situated in the County of Klamath, State of Oregon, bounded and described as follows:

Beginning at a point in the center of the channel of Lost River which is 30 feet northerly or upstream from the center of the Lost River Bridge on Klamath County Market Road number 3, or the Bonanza-Lorella North Road, thence northwesterly and westerly along the north boundary of said Market Road 125 feet, more or less, to the easterly line of West Avenue in East Bonanza or Shook's Addition, Klamath County, Oregon; thence along the easterly line of said West Avenue 50 feet, more or less, to the northeasterly boundary of the Horsefly Irrigation District in-take from Lost River; thence southeasterly along the northeasterly line of said in-take and said in-take boundary extended 160 feet, more or less, to the center or thread of the main channel of Lost River; thence southwesterly following the center or thread of said main channel of Lost River downstream 100 feet, more or less, to the point of beginning, being a portion of the SE^{1/4} of Sec. 10, Twp. 39 S.R. 11 E.W.M., formerly a part of East Bonanza or Shook's Addition, Klamath County, Oregon.
