KNOW ALL MEN BY THESE PRESENTS, That Clifford H. Kelly, also known as C. H. Kelly and Carolyn Kelly, his wife,

of County of Klamath State of Oregon,
in consideration of One Dollar and other valuable considerations Dollars,
to them paid by Ann Kelly,

of County of Klamath State of Oregon,
have bargained and sold, and by these presents do grant, bargain, sell and convey unto said Ann Kelly her heirs and assigns, all the following

bounded and described real property, situated in the County of Klamath and State of Oregon: All of our right, title and interest in and to the following:
The same being an undivided one half interest.
All of the NW^{1/4} of the SE^{1/4} Sec. 23, Twp. 39 S.R. 9 E.W.M., containing 40 acres more or less inclusive of the Govt. drain along the west boundary and the highway along the East boundary less and excepting the following part thereof.
Beginning at the point of intersection of the East boundary of the aforesaid NW^{1/4} of SE^{1/4} of said Sec. 23 and the southerly right-of-way boundary of the Great Northern Railway Co. right of way; thence south along said east boundary of the NW^{1/4} of SE^{1/4} Sec. 23 a distance of .66.0 feet; thence west parallel with the south boundary of said NW^{1/4} of SE^{1/4} Sec. 23, a distance of 1320 feet, more or less to the west boundary thereof; thence north along said west boundary, 97 feet, more or less to the northwest corner of said NW^{1/4} SE^{1/4} of said sec. 23; thence East along the north boundary thereof 1285.2 feet to the southerly right-of-way boundary of said Great Northern Railway Co. railroad; thence south 43° 22' E. along said right of way a distance of 46.6 feet, more or less to the point of beginning containing 2.04 acres more or less, inclusive of the Govt. drain along the west boundary and the highway along the east boundary and subject to any and/or all easements or rights of way of record and those agreement upon the land.
