 their heirs and assigns, all the following bounded and described real property, situated in the County of Klamath and State of Oregon:
 All of my right, title and interest in and to the following:
 The same being an undivided one half interest.
 All of the SW 1/4 of NE 1/4 of Sec. 23 Twp. 39 S.R. 9 E.W.M. in Klamath County, Oregon, excepting therefrom that portion containing 3.56 acres, more or less, deeded to the Great Northern Railway Co. described and recorded in Vol. 95 page 475 deed records of Klamath County, Oregon, subject to an apparent easment for Govt. drain along the west boundary and highway along the east boundary also any and all easments or rights of way of record or apparent upon the land.
 Excepting also a part of the NW 1/4 of SE 1/4 of said Sec. 23 Twp. 39 S.R. 9 being more particularly described as follows:
