KNOW-ALL MEN BY THESE PRESENTS, That LILLIAN G. MANN, a single woman, vendor in that certain contract of sale dated March 4, 1957, recorded March 7, 1957 in Volume 290 at page 215, Deed Records of Klamath County, Oregon, wherein William A. Bray and Ruby E. Bray, husband and wife, are vendees, does hereby release from the lien and terms and provisions of said agreement the following described premises situate in Klamath County, Oregon, to-wit:

PARCEL I: Beginning at a point in the SW1/4 of Section 8, Township 39 South, Range 9 East of the Willamette Meridian, which is North 0°43' West 250 feet from the one quarter corner common to Section 7 and 8 of said Township and Range; thence East 305.3 feet to a point; thence North 265.18 feet, more or less, to the most Southerly corner of a parcel of land described in a deed filed in Deed Records of Klamath County, Oregon, Volume 181 at page 175; thence North 45°09½' West 300 feet, more or less, to the Southeasterly right of way line of the Weed-Klamath Falls Highway, as the same is now located and constructed; thence South 44°50½' West along said right of way line, 138 feet, more or less, to its intersection with the West line of Section 8, Township 39 South, Range 9 East of the Willamette Meridian; thence South 0°43' East along said line, 379 feet, more or less, to the point of beginning, being a portion of the SW1/4 of Section 8, Township 39 South, Range 9 East of the Willamette Meridian.

PARCEL II: Beginning at a point on the East line of Section 7, Township 39 South, Range 9 East of the Willamette Meridian, which point is North 0°43' West 250 feet from the one quarter corner common to Sections 7 and 8 of said Township and Range; thence West 346 feet, more or less, to the Southeasterly right of way line of the Dalles-California Highway, as the same is now located and constructed; thence Northeasterly along said right of way line to its intersection with the East line of said Section 7; thence South 0°43' East along said Section line to the point of beginning, being a portion of the SE1/4 of Section 7, Township 39 South, Range 9 East of the Willamette Meridian;

and will execute and deliver to vendees a Bargain and Sale Deed for same herewith

That the consideration for this release is the payment of TWO THOUSAND and 00/100 (\$2,000.00) DOLLARS to vendor, receipt of which is hereby acknowledged, which said consideration is in addition to the present unpaid balance of said contract and does not alter or effect or decrease the present unpaid balance of said contract which is \$46,240.23 with interest thereon at the rate of 5% per annum from January 10, 1963.

That the remainder of the property described in the aforesaid contract of sale shall remain subject thereto as heretofore.
