6 TO THE HONORABLE JUDGE of the above entitled Court:

7 COMES NOW MARY WILLIAMS, of Salem, Marion County, Oregon,

8 and by this petition respectfully represents:

9 That George Duvall, above named, died at Burns, Harney
10 County, Oregon, on the 7th day of September, 1960, and left an
11 estate in Marion County, Oregon, of which he was a resident and
12 domiciliary at the time of his death. Said estate consisted of a
13 vested interest in the assets of the Klamath Indian Tribe of an
14 approximate value of Fifty Thousand and No/100 (\$50,000.00) Dollars;
15 that deceased was Eighty-Nine (89) years of age at the time of his
death.

16 At the time of his death, the decedent left as his sur-
17 viving heirs the following:

18 AMOS GEORGE DUVALL
19 MELVIRA TOFTHAGEN
20 MARY WILLIAMS

21 Due search and inquiry has been made to ascertain if said
22 deceased left any Will and Testament, but none has been found, and
23 according to the best knowledge, information and belief of your
24 petitioner, said deceased died intestate.

25 Your petitioner, Mary Williams, is over the age of majority
26 and a bona fide resident of the State of Oregon and is the daughter
27 of the deceased and is, in all respects, a competent and qualified
28 person to petition for appointment of Administratrix; and desires
29 to appoint her daughter, the decedent's granddaughter, Mary Lee
30 Haskins, of Clackamas County, Oregon, who is a competent and qualified
31 person to act as Administratrix of this estate, and who is a bona-
32 fide resident of Oregon.

1 ... fice resident of Oregon and over the age of 21.

2 There is no cash in this estate, and with the exception
3 of the interest set forth above, no other assets. None of the
4 interest set forth above can be reached by the Administratrix until
5 such time as the federal government sells the assets of the Klamath
6 Indian Tribe and makes a pro rata distribution to those entitled.
7 Therefore, a minimum bond of One Thousand and No/100 (\$1,000.00)
8 Dollars would be sufficient until such time as the federal govern-
9 ment makes a pro rata distribution.

10 It is necessary that said estate be administered upon at
11 once.

12 WHEREFORE, your petitioner prays for an order of this
13 Court appointing said Mary Lee Haskins as Administratrix of said
14 estate upon the filing of a bond in the amount of One Thousand and
15 No/100 (\$1,000.00) Dollars and that Letters Testamentary be issued
16 to him.
