KNOW ALL MEN BY THESE PRESENTS, that EDWIN E. DRISCOLL, in consideration of Ten Dollars and other valuable considerations to him in hand paid by C. L. LANGSLET, has sold, transferred and assigned, and by these presents does sell, transfer, assign and set over unto said C. L. LANGSLET all of his right, title and interest in and to the Trust Agreement dated September 16, 1941, which was recorded December 7, 1942, in Volume 151 at page 465, Klamath County Deed Records, and in further Trust Agreement between the same parties, or their successors, dated September 26, 1944. Description of the lands included in said Trust Agreements is as follows, to wit:

The West half (W $\frac{1}{2}$) of the Northwest quarter (NW $\frac{1}{4}$); all that part of the Southwest quarter (SW $\frac{1}{4}$) lying West of the recorded right of way of the California Northeastern Railway's railroad; all that part of Lot Six (6) lying West of said right of way; all that part of Lot Seven (7) lying West of said right of way; all in Section 1, Township 40 South, Range 8 East Willamette Meridian; the East half (E $\frac{1}{2}$) of the East half (E $\frac{1}{2}$); Lot Five (5); Lot Six (6); Lot Seven (7); Lot Eight (8); Lot Nine (9); all in Section 2, Township 40 South, Range 8 East Willamette Meridian; the East half (E $\frac{1}{2}$) of the Northeast quarter (NE $\frac{1}{4}$); the Southwest quarter (SW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$); the Southwest quarter (SW $\frac{1}{4}$); the West half (W $\frac{1}{2}$) of the Southeast quarter (SE $\frac{1}{4}$); all that part of the East half (E $\frac{1}{2}$) of the Southeast quarter (SE $\frac{1}{4}$) lying West of said right of way; Lot Two (2); Lot Three (3); Lot Four (4); Lot Five (5); all in Section 11, Township 40 South, Range 8 East Willamette Meridian; all that part of the Northwest quarter (NW $\frac{1}{4}$) lying West of said right of way in Section 12, Township 40 South, Range 8 East Willamette Meridian; the Northwest quarter (NW $\frac{1}{4}$), and all that part of the East half (E $\frac{1}{2}$) lying West of said right of way, all in Section 14, Township 40 South, Range 8 East Willamette Meridian; Lot Six (6) and Lot Seven (7) in Section 10, Township 40 South, Range 8 East Willamette Meridian, in Klamath County, Oregon; and

The Southwest quarter (SW $\frac{1}{4}$) of Section 14, Township 40 South, Range 8 East Willamette Meridian; the North half (N $\frac{1}{2}$) of the Southeast (SE $\frac{1}{4}$) quarter of Section 15, Township 40 South, Range 8 East Willamette Meridian; Lots 10, 11, 12, 13, 14 and 15 in Section 15, Township 40 South, Range 8 East Willamette Meridian, in Klamath County, Oregon, consisting of 389 acres, more or less.

TO HAVE AND TO HOLD the same unto said grantee, his heirs and assigns, forever.
