beginning at an iron pin on the West boundary of Homeale Road, said point being West a distance of 30.0 feet and South a distance of 20.0 feet from the Northeast corner of the SW 1/4 of said Section 14; thence South along the West boundary of Homeale Road a distance of 120.0 feet to an iron pin; thence West a distance of 130.0 feet to an iron pin on the easterly right of way line of Lateral F-5 (or lateral A-2-B); thence Northeasterly along said Easterly right of way line to a iron pin located West a distance of 525.0 feet from the above described beginning point; thence East a distance of 525.0 feet, more or less, to the point of beginning.
