Tract 13 and 14 of Subdivision of Tracts 25 to 32 inclusive together with the South 10 feet of 33 and 34 of Altamont Ranch Tracts, Klamath County, Oregon, according to the duly recorded plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

EXCEPT the East 10 feet thereof conveyed to Klamath County by Deed recorded in Vol. 168 at page 535 of Klamath County Deed Records.

Subject to: Contract and/or lien for irrigation and/or drainage, easements and rights of way of record and those apparent on the land, if any,
