Twenty thousand and 00/100 Dollars, with interest thereon at the rate of 6 per cent per annum from date until paid; payable in monthly installments of not less than \$495.10 in each payment, including the full amount of interest accrued on this note at time of payment of each installment. The first payment to be made on the 25th day of June, 1964, and a like payment on the same day of each succeeding month thereafter, until the whole sum, principal and interest, has been paid. If any of said installments is not so paid, the whole of said principal sum and interest shall become immediately due at the option of the holder hereof. If any of said installments is not so paid upon its maturity date, such installment shall bear interest from said maturity date at the rate of 8 per annum, and in case suit or action is instituted to collect this note, or any portion hereof, I promise to pay such additional sum as the court may adjudicate reasonable as attorney's fees, suit or action. Further, if I am in default in any payment, whether or not suit or action is instituted, I promise to pay all costs of collecting such delinquent payment.
